## **JOB SUMMARY / OVERVIEW**

PrairieStar Health Center is seeking a Licensed Specialist Clinical Social Worker (LSCSW) to provide counseling services to patients of all ages especially children. You will collaborate with our primary care and mental health team to provide integrated behavior health services including brief interventions as well as ongoing therapy.

## **PRIMARY DUTIES**

Every effort has been made to include all duties; however, the omission of a specific statement of duties does not exclude the duty from the position if the work is similar, related or is a logical assignment of the position.

- Provide comprehensive assessment and diagnosis of behavioral health clients
- Provide effective treatment planning and assisting clients in successfully achieving goals
- Evaluate crisis situations and apply appropriate interventions
- Actively participate in meetings that support PrairieStar's integrated health care model to provide comprehensive care for clients.
- Assist in the detection of "at risk" patients and development of plans to prevent further psychological or physical deterioration.
- Assist the primary care team in developing case management processes such as the use of guidelines, disease management techniques, case management and patient education to improve self-management of chronic disease.
- Provide assessment, consultation and brief intervention for psychological/psychiatric problems and disorders.
- Provide substance/use abuse evaluation, identification of maladaptive coping strategies, and development of harm reduction strategies.
- Plans and administers therapeutic treatment such as behavior modification and stress management therapy to assist patient in managing symptoms and underlying stressors.
- Change method and degree of therapy when indicated by client reactions.
- Develops appropriate treatment goals and discusses progress toward goals with client such as controlling weight, stress, substance abuse.
- Consults with medical doctor or other clinicians concerning treatment plan and amends plan as directed.
- Documents progress and treatment plan reviews.
- Evaluate crisis situations and apply appropriate interventions.
- Maintains electronic health records and reports in accordance with PrairieStar's policies and procedures.
